Thank you for deciding to purchase one of our puppies. We want to make this a stress free and enjoyable experience for you and your family. Please feel free to email us with any questions or concerns that you might have along the way. We will keep you up to date with all information regarding your puppy as it grows until it is time for you to take your new fur-baby home. Live camera feeds are available for you to watch as your puppy grows and to ensure the best care is being provided.

Please read the contract below completely before putting a deposit on a puppy. <u>By putting a</u> <u>deposit on a puppy, you are agreeing to the terms and conditions within this contract.</u>

- We require a <u>\$300-dollar non-refundable</u> deposit in order to reserve a puppy from our current litter. All deposits are made via PayPal.
- All puppies will go home with:
 - Current shots/de-worming and all medical records
 - American Stock Dog Registry registration paperwork including pedigree
 - * Personalized birth certificate,
 - A Microchipped -Prepaid Lifetime membership with BuddyID (for microchip tracking)

**Be certain that you are ready for the time commitment and financial responsibility of a puppy prior to making a deposit **

This contract is between Royal Aussies of Virginia, hereinafter referred to as SELLER and ______, hereinafter referred to as BUYER(s).

- 1) _____ The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy/dog parasite free and up to date with inoculations, proper nutrition, and fresh water available at all times. The Buyer promises to provide a safe environment for the dog, and never allow the dog to roam freely without proper fencing or supervision.
- 2) _____ The Seller guarantees this puppy/dog to be of sound health and temperament for the period of 2yrs from the date of purchase. A health record of all shots and worming's will be provided by the Seller. Should puppy/dog be determined to be in ill health, the cause of which is clearly attributable to an inherited genetic disorder, the dog may, upon signed written diagnosis from said veterinarian, be returned for refund of the purchase price or transfer purchase price to another puppy of their choice. If there is not an available puppy from the current litter the buyer will have first choice from next litter. The Seller will assume no responsibility if this puppy/dog is given any Aussie-sensitive drugs and suffers an adverse reaction. This health guarantee does not cover minor illnesses and health issues such as colds, allergies, internal or external parasites or umbilical hernias. However, the seller will disclose any known illnesses or health issues prior to the sale of the puppy. No other guarantees are given.
- 3) _____ All our puppies are genetically tested prior to being picked up for the presence of the MDR-1 (Multi-Drug Resistance Gene), all other gene traits are negative by percentage. If the gene is active this is not covered under the health guarantee. Buyer is aware that this puppy has been tested as _____ MDR-1 gene.

- 4) _____ The Buyer understands that the puppy is being sold <u>without breeding rights</u>. The buyer agrees that when registering the puppy, the last name "Royal" must remain to indicate bloodline. The Buyers agree not to use this animal for breeding and agrees to have it spayed/neutered at the age recommended by their veterinarian (usually 6 months to 1 year of age).
- 5) ______ If at any time the Buyer can no longer retain possession of this dog, the seller is to be notified and given first option of resuming full ownership of dog in order to locate this dog a new home. If returned within 30 days the buyer will receive a refund of half the paid price. The dog will be returned with all papers and medical records. The seller reserves the right to approve/prohibit any transfer of this animal to a third party. Under no circumstances will this dog be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility.
- 6) _____ The Buyer agrees to contact the Seller immediately if any questions or concerns arise about the dog, such as housing, diet, health or training. The buyer agrees to keep the seller informed of any major medical treatment as it occurs. This provides the seller with an opportunity to follow up on puppies and gives us important feedback and information on the health or our dogs for future generations.
- 7) _____ The Buyer understands that the seller does not guarantee size, eye color or ear type. The seller will provide the size and weight of both parents and an educated guess as to the puppy's potential full-grown weight. The seller does not guarantee fertility or ability to place in shows. The puppy is being sold as a top-quality companion pet. Training classes are recommended for a happy relationship between dog and family.

The preceding paragraphs contain conditions established to ensure the wellbeing of the dog, but also to uphold and maintain the reputation of quality that Royal Aussies of Virginia has established. The Buyer's agreements will continue for the dog's life and the Seller will have the right to enforce the agreements.
